AN EXECUTIVE ORDER ORGANIZING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) IN THE MUNICIPALITY OF PASACAO, CAMARINES SUR

WHEREAS, The State shall encourage non-governmental, community-based, or sectoral organizations that promote the welfare of the nation;

WHEREAS, Section 16 of The Local Government Code of 1991, states that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

WHEREAS, pursuant to the same law, each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian. For this purpose, the development council at the provincial city, municipal, or barangay level, shall assist the corresponding Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction.

NOW THEREFORE, by virtue of the power vested in me by law, it is hereby ordered that:

SECTION 1. The Municipal Development Council is hereby organized in the Municipality of Pasacao, Camarines Sur.

SECTION 2. The Municipal Development Council shall be composed of the following:

SECTION 3. The Municipal Development Council shall have the following roles, duties and functions:

- a. Formulate long-term, medium-term, and annual socioeconomic development plans and policies;
- b. Formulate the medium-term and annual public investment programs;
- c. Appraise and prioritize socioeconomic development programs and projects;
- d. Formulate local investment incentives to promote the inflow and direction of private investment capital;
- e. Coordinate, monitor, and evaluate the implementation of development programs and projects; and
- f. Perform such other functions as may be provided by law or competent authority;

SECTION 4. Meetings and Quorum. The local development council shall meet at least once every six (6) months or as often as may be necessary.

SECTION 5. Executive Committee. Each local development council shall create an executive committee to represent it and act in its behalf when it is not in session. The





composition of the executive committee shall be as follows:

Chairman: Municipal Mayor

Members: The chairman of the committee on appropriations of the Sangguniang Bayan
The Liga ng mga Barangay President
A representative of non-governmental organizations that are represented in the Council

SECTION 6. Sectoral / Functional Committees. There is hereby created sectoral/functional committees of the Municipal Development Council (MDC), composed of the following, viz;

SECTION 7. The Executive Committee shall exercise the following powers and functions:

- a. Ensure that the decisions of the council are faithfully carried out and implemented;
- b. Act on matters requiring immediate attention or action by the council;

- c. Formulate policies, plans, and programs based on the general principles laid down

- by the council; and
- d. Act on other matters that may be authorized by the council.

SECTION 8. Sectoral or Functional Committees. - The municipal development council may form sectoral or functional committees to assist in the performance of its functions.

SECTION 9. Secretariat. - There is hereby created a secretariat for the Municipal Development Council (MDC) which shall be responsible for providing technical support, documentation of proceedings. The secretariat shall be headed by the **Municipal Planning and Development Coordinator**.

SECTION 10. Project Monitoring Committee. There shall be a project monitoring committee in the municipality to monitor local development projects pursuant to Executive Order Memorandum Order No. 175 s. 1988, the Regional Project Monitoring and Evaluation System (RPMES) Manual of Operations and DILG Memorandum Circular 2004-78. A subsequent order shall be issued for this purpose.

SECTION 11. This Executive Order shall take effect immediately.
