EXECUTIVE ORDER NO. 004

"AN EXECUTIVE ORDER RECONSTITUTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF PASACAO, CAMARINES SUR"

WHEREAS, it is a declared policy of the state to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, risk reduction and management and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, Section 468 (a)(1)(iv) of the Local Government Code (RA 7160), states that it is the duty of the Municipal Government to adopt measures to protect the inhabitants of the municipality from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disaster and calamities:

WHEREAS, there is a need to reconstitute and strengthen the existing MDRRMC in order to enhance a coherent, integrated, proficient, and responsive emergency management system in the municipality and coordinate and implement projects and activities on civil protection, standard humanitarian assistance and disaster management;

WHEREFORE, IN VIEW FOREGOING, I, JORGE R. BENGUA, Municipal Mayor of the Municipality of Pasacao, Camarines Sur, Philippines, by virtue of power vested in me by law, do hereby order:

Section 1.Establishment of MDRRMC. – There shall be established in the Municipality of Pasacao, Camarines Sur, a Local Disaster Risk Reduction and Management Council to be known as Municipal Disaster Risk Reduction and management Council or MDRRMC;

Section 2.Composition. – The new MDRRMC shall be composed of the following:

Section 3. Functions. The MDRRMC shall have the following functions:

- 1. Approve, monitor and evaluate the implementation of the LDRRMP and regularly review and test the plan consistent with other national and local planning programs;
- 2. Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;
- 3. Recommend the implementation of forced or preemptive evacuation of local residents, if necessary; and
- 4. Convene the local council once every three months or as necessary.

Section 4. Meetings. – Pursuant to Item No. 4, Section 3, this Executive Order, the Council shall hold meetings once every three (3) months or as may be necessary and/or as called for by the Chairperson;

Section 5.Amendatory Clause. – This order amends all existing Local Executive Orders or other previous issuances inconsistent herewith;

Section 6.Effectivity. – This order takes effect upon its issuance.
