



**EXECUTIVE ORDER NO. 06**

**AN ORDER REORGANIZING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL OF THE MUNICIPALITY OF PASACAO, CAMARINES SUR AND DEFINING THE ROLES AND RESPONSIBILITIES THEREOF**

**WHEREAS**, the Constitution mandates that the government shall promote the quality of life of the people.

**WHEREAS**, Section 16 of the Local Government Code of 1991 provides that local government units shall pursue undertakings to improve public morals and maintain peace and order, among other equally significant concerns;

**WHEREAS**, the increasing use of illegal drugs has significantly contributed to the rise of criminality which necessitate a more aggressive and unified stance against illegal drugs to help ensure community peace and harmony;

**WHEREAS**, DILG Memorandum Circulars 98-227, 99-230, 2001-90, and 2003-131 direct all local government units to organize their respective Local Anti-Drug Abuse Council, in furtherance of all government efforts to address the above-mentioned problem, and provide guidelines thereof;

**NOW THEREFORE**, I, **JORGE R. BENGUA**, Municipal Mayor, Municipality of Pasacao, Camarines Sur, by virtue of the powers vested in me by law, do hereby order for the Creation of the Municipal Anti-Drug Abuse Council:

**Section 2: ROLES AND RESPONSIBILITIES**





- Serve as a focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
- Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future
- Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise;
- Conduct information and education campaign on the ill-effect of illegal drugs, monitor and report to proper authorities drug-pushers and drug-users in their locality;
- Prepare a confidential watch list of drug users and pushers found in the LGU's area of jurisdiction to be submitted to the PNP Anti-Illegal Drug Task Force for the latter's validation or verification leading to the arrest and filing of appropriate charges; and
- Perform other related responsibilities as may be assigned by competent authorities.

**Section 3: BUDGET.** The cost of implementing the programs, projects, and activities of the council shall come from the MPOC Budget and other related fund sources.

**Section 4. MUNICIPAL TASK FORCE KATAID (K**AbarangayKo, **T**Atabangan kong **I**wasan an **D**roga). In line with DILG RMC 2016-015 a municipal composite team under the Municipal Anti-Drug Abuse Council is also hereby created to be composed of the following:

**Section 5. Roles and Responsibilities of Task Force KATAID:**

1. Provide Full Support to OPLAN TOKHANG being spearheaded by the PNP;
2. Ensure that the process in handling SDUs will be implemented properly;
3. Identify issues/concerns and actions to be taken at the local level;
4. Study strategic options for the convergence of delivery of basic services;
5. Make recommendations to higher level to address pressing issues; and
6. Ensure the integration of the P/P/AS of the Task Force in the Peace and Order and Public Safety (POPS) plan of the R/P/C/M/BPOC and allocate funds for such.

3. Submit reports required by higher levels; and
4. Perform other related tasks assigned from time to time
