



## EXECUTIVE ORDER NO. 09

### AN ORDER REORGANIZING THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN (MCPC) OF THE MUNICIPALITY OF PASACAO, CAMARINES SUR

**WHEREAS**, the child and youth Welfare Code 1974 (PD 603) provides, among others, that local Government Units (LGUs) organize Local Council for the Protection of Children (LCPC) that will draw up and implement programs for child welfare and development;

**WHEREAS**, likewise, the Department of the Interior and Local Government (DILG), Memorandum Circular No. 2002 – 121, dated 05 August 2002, enjoins the organization of LCPC at the municipal level. The Memorandum Circular No. 121 pursues fundamental equality between men and women, and addresses the needs of abandoned and neglected children through alternative family arrangements;

**NOW THEREFORE, I JORGE R. BENGUA**, Municipal Mayor of Pasacao, by virtue of powers vested upon me by law do hereby order the following:

**SECTION 1.** The Municipal Council for the Protection of Children (MCPC) is hereby re-organized to be composed of the following:

**SECTION 2.** The Municipal Council for the Protection of Children (MCPC) shall have the following functions responsibilities:

1. Formulate plans, programs and policies for children that are gender- fair, culturally relevant and responsive to the needs of diverse of children from 0 to below 18 years of age;
2. Prepare Annual Work and Financial Plan (AWFP) for children and recommend appropriation to the Sanggunian;
3. Provide coordinative linkages with other agencies and institutions in the planning monitoring and evaluation of plans for children;
4. Provide technical assistance and recommend financial support to the Barangay Council for the Protection of Children (BCPC);
5. Establish and maintain database on children in the municipality
6. Recommend local legislation promoting child survival, protection, participation and development, especially on the quality of television shows and media prints and coverage, which are detrimental to children, and with appropriate funding support;
7. Conduct capability building programs to enhance knowledge and skills in handling children's program;
8. Foster education of every child;
9. Advocate for the establishment and maintenance of playgrounds, day care centers and other facilities necessary for child and youth development;
10. Assist children in need of special protection and refer cases filed against child abuser to proper agencies/institutions;
11. Document barangay best practices on children;
12. Monitor and evaluate the implementation of the program and submit quarterly reports to the Provincial Council for the Protection of Children (PCPC); and
13. Perform such other functions as provided for in child related laws;

**SECTION 4. Effectivity.** This Executive Order shall take effect immediately.
