



## EXECUTIVE ORDER NO. 011

### AN ORDER RECONSTITUTING LOCAL CLIMATE CHANGE ACTION PLAN (LCCAP) CORE TEAM OF THE MUNICIPALITY OF PASACAO, CAMARINES SUR

**WHEREAS**, The Local Government Code of 1991 (R.A 7160) mandates the Local Government Units to share with the National Government the responsibility in the management and maintenance of ecological balance in their respective territorial jurisdiction;

**WHEREAS**, Section 11 (2) of R.A 10121 (Disaster Risk Reduction and Management Act of 2010), provided that the LGU shall ensure the integration or mainstreaming of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;

**WHEREAS**, Section 14 of the Republic Act 9729 (Climate Change Act 2009) as amended by R.A 10174 (People's Survival Fund Act), provides among others that the LGU shall be the frontline agencies in the formulation, planning and implementation of Climate Change Action Plans (CCAP) in their respective areas, consistent with the provisions of the Local Government Code, the Framework and the National Climate Change Action Plan;

**WHEREAS**, the LGU Guidebook on the formulation of the Local Climate Change Action Plan also provides that the Local Chief Executive shall form the LCCAP Core Team who will lead, oversee and ensure that Local Climate Change Action Plan (LCCAP) will be formulated, eventually approved, implemented, regularly monitored and updated when necessary.

**NOW THEREFORE**, I, **JORGE R. BENGUA**, **Municipal Mayor of Pasacao, Camarines Sur**, by virtue of the powers vested in me by law, do hereby order the creation of Local Climate Change Action Plan Core Team:

**SECTION 1. COMPOSITION.** The Local Climate Change Action Plan (LCCAP) Core Team shall be composed of the following:

2. Identify programs and schemes relevant for implementation of the activities identified in the Climate Change plans;
3. Oversee and ensure that an LCCAP is formulated and implemented upon approval by the Office of the Sangguniang Bayan.
4. Coordinate the necessary communication and collaboration with all relevant departments of the LGU and other stakeholders;
5. Regularly monitor and update when necessary the LCCAP.

**SECTION 3. EFFECTIVITY.** This Executive Order shall take effect immediately and shall remain in full force and effect until repealed or modified.
