AN ORDER DECLARING AUGUST 29 AND 30, 2022 AS LOCAL HOLIDAYS IN THE MUNICIPALITY OF PASACAO, CAMARINES SUR IN VIEW OF THE CELEBRATION OF THE 127TH PASA-PASA IKAW FESTIVAL 2022 AND 137TH ANNUAL TOWN FIESTA

WHEREAS, in the above cited dates of 29th and 30th of August is the culminating dates for the festivities, revelries and celebrations both in this Local Government Unit and the Parish Catholic Church of Pasacao that dates back to the Spanish period when the town was founded in 1872 ;

WHEREAS, in these dates, traffic congestions, influx of tourists, visitors, pilgrims and devotees of St. Rose of Lima, Patron Saint of Pasacao, in celebration of the 137th Annual Town Fiesta of this municipality and being the Summer capital of Camarines Sur, are natural occurrences;

WHEREAS, in order to manage the flow of people and vehicles to and from this municipality, traffic re-routing schemes are readily adopted, and on these dates occur the conduct or observance of the Military and Civic Parades whose participating contingents come from municipalities in the province of Camarines Sur, this Local Government Unit necessitates the declaration of Local Holidays on this 29th and 30th of August, 2022 to give way to this yearly celebration;

WHEREAS, Section 16 of the Local Government Code expressly granted the Local Government Unit with authority to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

NOW, THEREFORE, by the power vested in me by law and keeping with our century old custom and tradition, I, JORGE R. BENGUA, Municipal Mayor of Pasacao, Camarines Sur, do hereby declare that August 29th and 30th of 2022 as LOCAL HOLIDAYS in the Municipality of Pasacao, Camarines Sur;

FURTHER, National Offices of Government and its instrumentalities holding offices in the municipality of Pasacao, Camarines Sur are hereby enjoined/ encouraged in the observance of this Local Holidays;

HOWEVER, offices that are duty-bound to maintain Peace & order, Emergency Rescue and Health Services, among others, such as the PNP, BFP, PPSO, BFAR, PPA, PMU, Public Market, Pasacao Public Terminal, MEO, LDRRMO, MENRO including street cleaners and garbage collectors, Municipal Health Office including birthing facility, and other personnel directly involved in the preparation of Civic parade shall remain open 24 hours a day, and could maintain a skeletal workforce sufficient enough to address the possible needs of the general public.

AN ORDER CREATING THE BARANGAY YOUTH DISASTER RISK REDUCTION AND MANAGEMENT PLAN (BYDRRMP) FORMULATION CORE TEAM OF PASACAO, CAMARINES SUR

WHEREAS, Art. II, Sec. 13 of the Philippine Constitution provides that "the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs";

WHEREAS, Republic Act 10121 otherwise known as the Philippine Disaster Risk Reduction and management Act of 2010 promotes the participation of civil society organizations (CSOs), the private sector and volunteers in the government's disaster risk reduction programs towards complementation of resource and effective delivery of services to the citizenry;

WHEREAS, Republic Act 10742 or the Sangguniang Kabataan (SK) Reform Act of 2015 provides for the formulation of the Comprehensive Barangay Youth Development Plan (CBYDP) as basis in the preparation of the Annual Barangay Youth Investment Program (ABYIP) and that it shall give priority to PPAs that will promote and ensure the meaningful youth participation in environmental protection, climate change adaptation, and disaster risk reduction and resiliency, among others;

WHEREAS, DILG-NYC Joint Memorandum Circular No. 2015-01 enjoins all Local Chief Executives to engage the youth sector in disaster risk reduction and management, integrate youth-oriented disaster activities in the LDRRMP and adopt the concept of WEmboree as a mechanism to strengthen youth volunteerism;

WHEREAS, on July 29 2022, DILG Regional Office V issued Regional Memorandum Circular No. 2022-006, entitled: "Guidelines on the Formulation of Barangay Youth Disaster Risk Reduction & Management Plan (BYDRRMP)" to enjoin and provide guidance to all Sangguniang Kabataan in the formulation of their respective BYDRRMP and LCEs to encourage their Sangguniang Kabataan to participate in the WEmboree and all other activities harnessing youth participation in disaster risk reduction and management and climate change adaptation and mitigation activities;

NOW, THEREFORE, I, JORGE R. BENGUA, Municipal Mayor of Pasacao, Camarines Sur, by virtue of the powers vested in me by law, do hereby order the creation of the Barangay Youth Disaster Risk Reduction and Management Plan (BYDRRMP) Formulation Core Team of Pasacao, Camarines Sur.

SECTION 1. COMPOSITION. The Barangay Youth Disaster Risk Reduction and





Management Plan (BYDRRMP) Formulation Core Team (BFCT) shall be composed of the following:

SECTION 2. FUNCTIONS. The Barangay Youth Disaster Risk Reduction and Management Plan (BYDRRMP) Formulation Core Team shall have the following functions and responsibilities:

- 1. Provide the necessary administrative and technical assistance to the Sangguniang Kabataan in the formulation of their respective BYDRRMP, such as:
 - a. Formulate BYDRRMP Roll-out Action Plan;
 - b. Conduct of Risk Assessment Communication to Sangguniang Kabataan Chairpersons if deemed necessary;
 - c. Generate data sets as reference of the BYDRRMP; and
 - d. Conduct of the BYDRRMP Roll-out
- 2. Conduct review of the BYDRRMP to ensure linkage to the Local Disaster Risk Reduction and Management Plan, Philippine Youth Development Plan and Local Youth Development Plan;
- 3. Conduct monitoring on the progress of BYDRRMP formulation;
- 4. Ensure timely submission of the BYDRRMP; and
- 5. Provide assistance to the Sangguniang Kabataan Council in outsourcing possible program, project and activity - funding support from various levels of government units, government agencies, private organizations and non-government organizations.

SECTION 3. EFFECTIVITY. This Order shall take effect immediately.
