AN ORDER RECONSTITUTING THE MEMBERS OF THE LOCAL HEALTH BOARD OF THE MUNICIPALITY OF PASACAO, CAMARINES SUR

WHEREAS, Article II, Section 15 of the 1987 Philippine Constitution, which states that “the State shall protect and promote the right to health of the people and instill health consciousness among them” and Article XIII, Section 11, which states that “the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost and there shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children.”

WHEREAS, Section 102 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, which states that a local health board should be established in every province, city, or municipality. And such provision also provides for the composition of the board;

NOW THEREFORE, I, **JORGE R. BENGUA**, Municipal Mayor, Municipality of Pasacao, Camarines Sur, by virtue of the powers vested in me by law, do hereby order the creation of the Local Health Board to wit;

Section 1. COMPOSITION. The Composition of the Local Health Board of this LGU is as follows:

SECTION 2. Functions. The LHB shall have the following functions:

1. To propose to the Sangguniang Bayan concerned, in accordance with standards and criteria set by the Department of Health, annual budgetary allocations for the operation and maintenance of health facilities and services within the municipality.
2. To serve as an advisory committee to the Sanggunian concerned on health matters such as, but not limited to, the necessity for, and application of, local appropriations for public health purposes; and
3. Consistent with the technical and administrative standards of the Department of Health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards grievances and complaints, personnel discipline, budget review, operations review and similar functions.
