



EXECUTIVE ORDER NO. 014

AN ORDER RECONSTITUTING THE MUNICIPAL TOURISM DEVELOPMENT COUNCIL OF PASACAO AND DEFINING ITS DUTIES AND FUNCTIONS

WHEREAS, the state declares tourism as an indispensable element of the national economy and an industry of national interest and importance, which must be harnessed as an engine of socio-economic growth and cultural affirmation to generate investment, foreign exchange and employment, and to continue to mold and enhanced sense of national pride of all Filipinos;

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, Local Government Units (LGUs) shall prepare, adopt, implement and monitor their local tourism purposes;

WHEREAS, LGUs shall adopt the principle of sustainable tourism development in the formulation of their local tourism development plans to give due regard to the conservation of natural endowments and preservation of cultural heritage while according opportunity for local communities to achieve a better quality of life;

NOW THEREFORE, I JORGE R. BENGUA, Municipal Mayor of Pasacao, Camarines Sur by virtue of the power vested in me by law do hereby order the constitution of the Municipal Tourism Development Council as a coordinating and advisory body for the Municipal Tourism Development efforts.

- Assist in the regulation and supervision of tourism-oriented establishments thereby ensuring wholesome and clean tourism activities;
