EXECUTIVE ORDER NO. 022

AN ORDER REORGANIZING THE LOCALIZED PEACE ENGAGEMENT TEAM OF THE MUNICIPALITY OF PASACAO, CAMARINES SUR

WHEREAS, President Rodrigo Duterte issued Executive Order No. 70 entitled Institutionalizing the Whole-of Nation Approach in Attaining Inclusive and Sustainable Peace, creating a National Task Force to end Local Communist Armed Conflict and Directing the adoption of a National Peace Framework;

WHEREAS, the Executive Order No. 70, which created the National Task Force, provides for the establishments of mechanism for local peace engagements or negotiations or interventions, that is nationally orchestrated, directed and supervised while being locally implemented;

NOW THEREFORE, I, JORGE R. BENGUA, Municipal Mayor of Pasacao, Camarines Sur, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION. - The Localized Peace Engagement Team shall be composed of the following:

SECTION 2. FUNCTIONS: The Localized Peace Engagement Team shall:

- A. Conduct community-problem solving sessions to validate the needs and problems noted by the Retooled Community Support Program Operations.
- B. Formulate the agenda. This should reflect the result of the consultations with the community. It may also include other concerns to humanize the armed conflict.
- C. Conduct feedback assembly with the community to report on the resolution of major issues.
- D. Consolidate unresolved problems and issues to be presented to the concerned agencies in the province through the PTF-ELCAC. Feedback on the status will be given to the community concerned.
- E. Hold the local level formal peace dialogues to discuss and agree on a joint local-level peace agreement. The following principles shall form part of the foundation of any dialogue with the armed rebel group:
- 1. The Philippine Republic is the only sovereignty. The government will never accord belligerency status to any armed group.
- 2. The resolution of any issue or the response to any demand shall always be within the bounds of the Philippine Constitution and the amid of law.
- 3. The Localized Peace Engagement Team shall always consult the Provincial TF-ELCAC regarding any demand or issue that involves a question of national policy or security prior to making any comment.
- 4. Provide regular progress to the Provincial TF-ELCAC regarding the status of local peace engagement.
- F. Submit to the Provincial TF-ELCAC the draft joint local-level peace engagement for approval.
- G. Implementing agreements. Monitor and evaluate compliance to agreement.
- H. Sign Completion/Exit Agreement.

SECTION 3. MEETINGS. -The Localized Peace Engagement Team shall meet every quarter or as often as may be necessary.

SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately.
