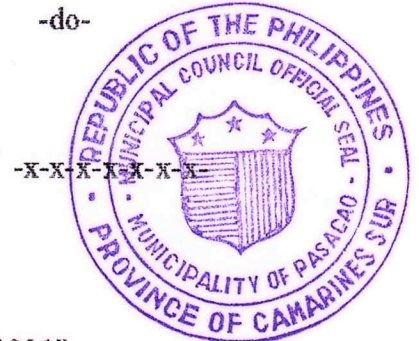

"IN SUPPORT TO MUNICIPAL ORDINANCE NO. 01, S. 2001"

WHEREAS, presented to this August Body is the Petition for Trimobile Fare Increase by the Balogo Trimobile Operators Drivers Association (BATODA) for route Balogo – Poblacion and Vice Versa;

WHEREAS, said petition was acted upon by the Committee on Transportation and Communications, and due public hearings/ consultations were conducted at Barangay Balogo whereby public sentiments were gathered thereat;

WHEREAS, upon appropriate deliberations on the various concerns presented, this August Body has unanimously reached a Compromised Fare Increase agreeable to all parties involved, considering the present economic difficulties;

WHEREAS, said trimobile fare deliberated and reached are as follows:

MUNICIPAL ORDINANCE NO. 01, S. 2001

AN ORDINANCE GRANTING TRIMOBILE FARE INCREASE FOR BALOGO – POBLACION AND VICE VERSA ROUTE



BE IT ORDAINED by this Honorable Sangguniang Bayan that :

SECTION I ESTABLISHED FARES:

	OLD FARE	NEW FARE (PROPOSED)	COMPROMISED FARE
STUDENTS	P 3.00	P 4.00	P 3.00
SENIOR / DISABLED CITIZENS	P 3.00	P 4.00	P 4.00
REGULAR PASSENGERS	P 5.00	P 6.00	P 6.00

SECTION II MISCELLANEOUS PROVISION That during Saturdays, Sundays and/ or non – school days, students shall be charged for regular fares, except when students are having CAT or CMT Trainings and other related student/ school activities.

SECTION III PENAL PROVISION Violation of any provision of this ordinance shall subject the violators to administrative fines of:

P 100.00 for 1st Offense
200.00 for 2nd Offense
300.00 for 3rd Offense

SECTION IV. REPEALING PROVISION All ordinances, regulations or parts thereof which are inconsistent with the provisions of this ordinance are hereby repealed and/ or modified accordingly.

SECTION V. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.


