**WHEREAS**, the DALUPAON NATIONAL HIGH SCHOOL - Annex (Bahay High School) was established in 1998 at Barangay Bahay, this municipality, through the efforts of incumbent Honorable Mayor Manuel SA. Lee-Oliver, Jr. and the Honorable Sangguniang Bayan under the stewardship of Honorable Vice Mayor Renerio D. Borjal and most especially through the able support of incumbent Honorable Congressman Rolando G. Andaya, Jr.;
