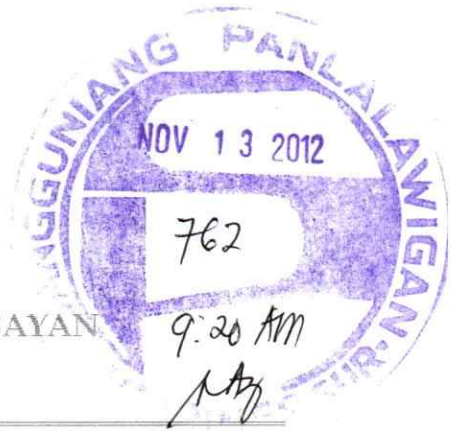

AN ORDINANCE ESTABLISHING THE BARANGAY BALOGO TO PASACAO PUBLIC CENTRAL TERMINAL AND VICE VERSA TRIMOBILE-FOR-HIRE ROUTE IN THE MUNICIPALITY OF PASACAO, CAMARINES SUR

BE IT ORDAINED by this Honorable Sangguniang Bayan in en banc session assembled, that:

SECTION I. TITLE: This ordinance shall be known as AN ORDINANCE ESTABLISHING THE BARANGAY BALOGO TO PASACAO PUBLIC CENTRAL TERMINAL AND VICE VERSA TRIMOBILE-FOR-HIRE ROUTE IN THE MUNICIPALITY OF PASACAO, CAMARINES SUR.

SECTION II. TRIMOBILE-FOR-HIRE ROUTE AND COVERAGE. This trimobile route will originate from Barangay Balogo Proper and to end at final destination of ~~Public~~ ^{Pasacao Public} Central Terminal and Vice Versa.

SECTION III. MISCELLANEOUS PROVISION.

a) Under this trimobile route, only twenty (22) trimobile franchise slots are allowed to operate public conveyance services as duly registered with the Honorable Sangguniang Bayan of this municipality;

b) That passenger capacity shall not be more than (10) persons per trimobile to assure passenger safety while in transit;

c) That trimobile operators shall see to it that its respective trimobile franchise, vehicle LTO registrations and drivers licenses, Passengers and Third Party Liability Insurances are in order and updated;

SECTION IV. PENAL PROVISION.

Violations of provisions of this ordinances shall subject the offender to suffer the penalty of the following upon conviction of the Court:

- 1st Offense - A fine of P 500.00
- 2nd Offense - A fine of P 1,000.00
- 3rd Offense - A fine of P 1,500.00

SECTION V. SEPARABILITY CLAUSE. In the event that some provisions of this ordinance or parts thereof are declared unconstitutional, the other parts not so affected, shall remain in full force and effect.

SECTION VI. REPEALING CLAUSE. All ordinances, rules and regulations or parts thereof whose provisions are in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended, or modified accordingly.

SECTION VII. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.


